



**ENGAGEMENT ACT**

**SECTION 1- Purpose of the Consultation and the Deed of Commitment**

This act of commitment corresponds to the basic offer to the Consultation referenced C18/23, launched by the Central Purchasing Center for Essential Medicines and Medical Equipment of Madagascar "SALAMA", for the Supply of MEDICAL CONSUMABLES AND LABORATORY REAGENTS..

**ARTICLE 2 -Commitment**
